About the Medical Advisory Council (MAC)

The MAC provides expert medical guidance and recommendations to the Accessia Health Board of Directors to ensure the organization remains at the forefront of advances in healthcare and supports the charitable goals of the organization. Council responsibilities include:

- Review and provide recommendations on disease funds and clinical program needs in accordance with medical best practices
- Evaluate potential offerings including by providing assessments of emerging medical technologies and treatments
- Provide insights into healthcare trends and their impact on the charitable mission of the organization
- Assist in developing strategies to enhance patient and program outcomes, as well as patient experience
- Review and comment on medical aspects of the organization's plans and major initiatives, consistent with the organization's charitable mission and its compliance obligations

- Serve as a liaison between the clinical staff and the Board of Directors

Council Membership

The MAC will consist of 3–7 members, including:

- The VP of Clinical Strategy and Patient Engagement (ex-officio)
- 3–5 practicing physicians representing key specialties
- 1–2 external experts in healthcare or academia

Eligibility Requirements

Members must be independent of any Donor or Prospective Donor and their affiliates, meaning that members and their immediate family members must not receive direct or indirect compensation from such entities. Annual conflict of interest disclosures and compliance training are required. Members will serve 2-year terms, with the option for reappointment, and are expected to uphold the highest standards of confidentiality and ethics.

Meeting Commitment

- The MAC meets quarterly, with additional meetings scheduled as needed.
- All meetings are conducted with advance notice and documented with formal minutes.
- Members serve on a volunteer basis and contribute meaningfully to the organization's goals.
